A student may apply for a College Award(s), or may be nominated by a fellow student, by a member of the faculty, or by others in the College community. There are three College Awards for which a student may apply or be nominated: the **PRESIDENT ROSSER PRIZE**, the **INTERNATIONAL HOUSE PRIZE** and the **STEVE STAFFORD MEMORIAL CONTINUING EDUCATION AWARD**.

A summary of the criteria for each award is given below. Please consult your department, the Registrar's Office or the College Calendar if you wish further information.

THE PRESIDENT ROSSER PRIZE

A medal and monetary prize are awarded to a graduating student of a post-secondary certificate or diploma program whose performance within the College community has been outstanding in terms of leadership and participation in student activities and who, as well, has maintained a good standard of scholastic achievement in his/her studies.

THE INTERNATIONAL HOUSE PRIZE

A certificate and monetary prize are awarded to a graduating student of a two or three-year diploma program, attending Algonquin College on a student visa who has maintained a high standard of academic excellence throughout his/her program, and has been an active participant in extracurricular activities within the College community.

THE STEVE STAFFORD MEMORIAL CONTINUING EDUCATION AWARD

A plaque and monetary prize are awarded to a student demonstrating unusual or extra effort while having completed a Continuing Education Diploma/Certificate or having completed the majority of a Post-Secondary Program through Continuing Education.
