REQUEST TO AUDIT A CREDIT COURSE

Because of the nature of the course, class size restrictions, space constraints, possible legal restrictions, and/or safety factors, permission of the appropriate Academic Administrator is required for registration with audit status. Students should be aware that audit status is a privilege, not a right, and that pre-requisites and/or co-requisites, if any, of the course apply.

Audit and credit status must be declared at the time of registration. Credit status cannot be changed to audit status after the tenth day of classes in the day timetable or after the second scheduled class in the continuing education timetable. There is no distinction in fees between credit and audit. An audited course cannot be used to establish a full-time course load.
