Test/Quiz/Exam Accommodations

CAL Test Services (room E304e), provides **in-person** and **virtual** proctoring support on behalf of the faculty when accommodations cannot be delivered in the classroom environment.

To receive CAL Test Services support, students must submit their test/exam requests using the <u>CAL Student Portal</u> at least 7 days in advance and by the specified date indicated on the <u>CAL Test Services website</u> for final exams scheduled during Final Assessment Week.

For assessments that do not involve supervision, faculty are requested to implement the test accommodations outlined on the LOA.
