

## **Algonquin College, Campus Services "Winter 2024 Custom Hoodie Week Contest"**

### **February 2024 Gift Card Giveaway**

The Algonquin College, Campus Services "Winter 2024 Custom Hoodie Week Contest" (the "Contest") is administered by Algonquin College, Campus Services Department (the "Sponsor"). Any questions, comments or complaints regarding the Contest should be directed to the Sponsor at 1385 Woodroffe Ave, Nepean, Ontario, K2G 1V8 or (613) 727-4723 ext. 7082. By participating in this Contest, each contestant agrees to be legally bound by the Official Contest Rules.

#### **#1- Contest Period**

The contest begins on Monday, February 5, 2024, at 7:00 a.m. EST and ends on Sunday, February 11, 2024, at 11:59 p.m. EST. Entries received after 11:59 p.m. on February 11, 2024, will not be eligible to win.

#### **#2- Eligibility**

The Contest is open to all legal residents of Canada (excluding residents of Quebec and void where prohibited by law). The winner must coordinate picking up their prize at the Algonquin College Ottawa Campus within 14 days of being declared winner. This contest is not open to individuals associated with the Contest, including the Sponsor's employees, directors, agents, representatives, promotional and marketing agencies, and any member of the immediate families of any of the foregoing and other individuals with whom any of the foregoing individuals reside.

#### **#3- How to Enter**

To enter, eligible participants must either:

#### **#4- Prize**

Three (3) \$80 gift certificates to Connections: The Campus Store will be awarded. There are no prize substitutions or exchanges. Additional purchases and any costs associated with the Prize are the

responsibility of the winner. The Sponsor will not be responsible or liable for any possible damages or injuries that may occur as a result of the use of the Prize.

#### #5- Minors

In the event that the winner is under the age of 18 years (a “minor”), the winner’s guardian or parent will be required to assist the minor with all and any necessary documents or agreements in connection with being awarded the Prize in the Contest. Minors who enter must have consent of a parent or legal guardian in order to be eligible to receive any prizes. In the event that the winner is a minor, Algonquin College, Campus Services cannot directly communicate with the minor, his or her parent or legal guardian must e-mail to claim prize as well as be present to claim prize, complete skill testing question and Declaration & Release form. Contest is void where prohibited by law.

#### #6- Draw & Winner Selection Process

One (1) Contest Draw will be held on Monday, February 12, 2024, in the City of Ottawa, Province of Ontario. Three (3) winners will be randomly selected from all eligible Contest Entries if a) it was received during the Contest Period, and b) clearly follows the instructions for entry. All decisions regarding the Contest are final in all respects.

The selected winners will receive an email to the account they provide upon entering the contest on the and will have 72 hours to respond to claim their prize.

In order to be confirmed as a winner in this contest, a selected entrant must have: a) complied with and remain in compliance with these Contest Rules; b) correctly answer without assistance of any kind, a mathematical, skill-testing question and c) sign the Declaration and Release Form. The Sponsor reserves the right to verify the age of any selected participant eligible to win the prize.

If a selected participant does not respond within 72 hours, then they will be disqualified (and will forfeit all rights to the Prize) and the Sponsor reserves the right, in its sole and absolute discretion, to randomly select an alternate participant from among the remaining eligible entries (in which case the foregoing provisions of this section shall apply to such new selected participant).

The Sponsor will post the winners on the Algonquin College, Campus Services website and social media profiles once the prize winners have collected their prizes.

#### #7- General Terms & Conditions

By entering the Contest, you hereby agree and are bound by these General Rules and Regulations, which are subject to change without notice to Contest entrants.

- a. This Contest is governed by the laws of Canada. All federal and local laws and regulations apply.

- b. All decisions by the Sponsor with respect to all aspects of the Contest shall be final and binding. All entrants agree to abide by all of the instructions and decisions of the Sponsor. In the event of any dispute regarding the interpretation of these Rules or any decision rendered by the Sponsor, the decision or interpretation of the Sponsor shall prevail.
- c. By entering the Contest, an entrant consents to the use by the Sponsor of the personal information submitted with such entry both for the purpose of administering the Contest. In addition, by entering this Contest, an entrant consents to the use of such personal information by the Sponsor to contact the entrant before the Contest Closing Time to promote the Contest and Sponsor offers.
- d. The Sponsor reserves the right, in its sole discretion, to void any entry and/or withdraw, suspend, amend or terminate this Contest in whole or in part (or to amend these Rules) in any way at any time without prior notice (but subject to applicable law), in the event of an error, technical problem, computer virus, bugs, tampering, unauthorized intervention, fraud, technical failure or any other cause beyond the reasonable control of the Sponsor that, in the Sponsor's sole discretion determines, interferes with the proper conduct of this Contest as contemplated by these Rules, or in the event of any accident, printing, administrative, or other error or any kind, or for any other reason.
- e. The Sponsor also reserves the right, in its sole and absolute discretion, and without prior notice, to adjust any of the dates and/or timeframes stipulated in these Rules, to the extent necessary, for purposes of verifying compliance by any contestant or entry with these Rules, or as a result of technical problems, or in light of any other circumstances which, in the opinion of the Sponsor, in its sole and absolute discretion, affect the proper administration of the Contest as contemplated in these Rules.
- f. The Sponsor does not assume responsibility of any nature whatsoever where the inability to hold the Contest results from any event beyond the reasonable control of the Sponsor, including without limitation, any Act of God, any strike, lock-out or other labour conflict, war, act of terror, unavailability of any Website, or should a virus, worm, bug or other cause beyond the reasonable control of the Sponsor corrupt the security, data integrity, or proper administration of the Contest.

- k.
