April 13 – April 20, 2026	Program Outcomes Mapping Revisions for Program Modifications Curriculum Planning and Implementation Team enter revised Program Outcomes Maps for Academic Development supported Program Modifications and notifies Coordinators when complete.
April 13 – April 24, 2026	Program Outcomes Mapping Revisions for ACR Program of Study Changes (CAL999s) Program Coordinators submit revised Program Outcomes Maps as needed to support Program of Study revisions made during ACR on CAL999 documents. Ensure that any new courses are mapped and review the maps for any impact from Program of Study changes (i.e. course removal, moving courses between levels, etc.)
April 13 – May 8, 2026	Program Outcomes Mapping Revision Approval Curriculum Consultants in Academic Development review proposed map revisions, consult with Coordinators as needed, and approve mapping revisions to be pushed to program course outlines.
July 13, 2026	COURSE WRITER DUE DATE: FALL 2026 course outlines must be submitted to Program Coordinators.
July 20, 2026	PROGRAM COORDINATOR DUE DATE: FALL 2026 course outlines must be submitted to Chairs.
July 27, 2026	CHAIR DUE DATE: APPROVAL of <u>ALL</u> FALL 2026 course outlines. <i>(Note: many depts/faculty work ahead for Winter/Spring)</i>

November 23, 2026	PROGRAM COORDINATOR DUE DATE: WINTER 2027 course outlines must be submitted to Chairs.
November 30, 2026	CHAIR DUE DATE: APPROVAL of <u>ALL</u> WINTER 2027 course outlines.
