## First Quarter 2022-23 Financial Projection

The following updates have been made to the College's Adaptive Planning model to improve the user experience:

- Full-time and Part-time Salary Sheets For the salary formulas to calculate correctly, the mandatory columns have been identified with a "\*" in the column title.
   LEGAL NAME\* BASEPAY\* BASE PAY FREQUENCY\* DEFAULT WEEKLY HOURS\*
- As communicated last year, a standardized Income Statement Summary report is available in Adaptive Planning within *Reports > Shared > Corporate Templates* sub-folder and is titled "Income Statement Summary 2022-23".
- The organization of the Shared Matrix Reports folder in Adaptive Planning will also be reorganized to provide more structure for all users. Changes to the folder structure will take effect on the morning of Friday, June 17, 2022 and additional information on the new structure including guidelines on maintenance of shared files is available on the FIN Adaptive Planning Resources Teams site under the Report Templates channel.
