SUBJECT: Annual Budget 2023-24 Process

Please share this memo with the appropriate staff in your department.

The Annual Budget 2023-24 process is well under way with a focus on restoring financial sustainability for the College. This will require budget holders across the College to maintain our efforts regarding fiscal responsibility in the current fiscal year and continuing into 2023-24.

Though we are unable to release budget targets at this time, Adaptive Planning will be open on November 1, 2022 for data review and input as per the following timelines:

Annual Budget 2023-24 Area Targets

In consultation with the Algonquin College Executive Team, work continues to finalize the five-year pro forma which is used to develop Area level budget targets. This work is not expected to be finalized until mid-November so Area Targets will not be distributed until that time.

Full-Time Salaries (Non-Academic Areas)

Similar to last year, all Non-Academic Areas will have their full-time salaries loaded into Adaptive Planning at 100% of the full-time complement report and no adjustments should be necessary. However, we do suggest you review the Full-Time Salaries Sheet to ensure accuracy. For part-time & temporary salaries, only true part-time salary data is required (i.e. do not include backfill costs for vacant full-time positions).
