## First Quarter 2023-24 Financial Projection

Finance will be producing a First Quarter 2023-24 Financial Projection report that will identify any significant changes to the 2023-24 Approved Annual Budget. This report will be presented to the following committees (dates subject to change):

•	College Budget Committee	September 21, 2023
•	Audit & Risk Management Committee	September 21, 2023
•	Board of Governors	October 23, 2023

For this update, we are focused on significant changes and are asking departments to update their projections for any major variances (revenue or expenditure variances greater than \$250,000). Please ensure these updates are reflected in Adaptive Planning by making changes to the version titled **Q1 Projection 2023-24**. During this First Quarter Financial Projection process, the Corporate Planning team may reach out to departments to discuss their updated projections for the year.

Adaptive Planning will be available for First Quarter Projection updates during the following period:

•	Adaptive Planning opens for Q1	June 5, 2023 @ 9:00 a.m.
•	Adaptive Planning closes for Q1	July 21, 2023 @ 4:00 p.m.

## **Adaptive Planning Enhancements and Fixes**

The following updates have been made to the College's Adaptive Planning model to improve the user experience:

- 1. Leave calculations based on data inputted onto the Full Time Salaries Employee Data sheet have been corrected.
- 2. Public College Private Partnership tuition and premium revenue calculations have been added to the Academic Revenue sheet.
- 3. Several student fee revenue calculations have been automated on the new sheet labelled Student Fee Calculations.
