Helpful information

- IRCC regulates your stay in Canada as an International student. This includes your eligibility to work in Canada.
- Having a Social Insurance Number (SIN) does not mean you can work as much as you like. You are expected to follow IRCC rules and regulations.
- You have the same rights as Canadians and Permanent Residents (few exceptions).
- Be aware of Scams. If you feel that, something is not right a threat or promise for something that is too good to be true, ask to be sure. See more on IRCC's website here: https://www.canada.ca/en/immigration-refugees-citizenship/news/notices/scam-international-students-april2018.html
- If you want to be eligible to work while studying in academic studies as well as for the Post-Graduate Work Permit (PGWP) in future, it is recommended that you remain a fulltime student.
- You must stop working on the day you no longer meet eligibility requirements (e.g., if you are no longer a full-time student.)

As an international student with a study permit you must:

- always be enrolled at a DLI
- make progress towards completing your program
- respect any conditions listed on your study permit
- · stop studying if you no longer meet the requirements, and
- leave Canada when your permit expires

Social Insurance Number (SIN)

You need a <u>SIN</u> from Service Canada to work in Canada or to get benefits and services from government programs.

To apply for a SIN to work on campus, your study permit must have these conditions printed on it:

- May accept employment on the campus of the institution at which registered in full-time studies
- May accept employment on or off campus if meeting eligibility criteria as per R186(f), (v) or (w). Must cease working if no longer meeting these criteria

Important IRCC

You can amend if a mistake was made or change the conditions of your study permit to have the remark added.

<u>Off-Campus Work</u> - As of June 1, 2014, you may qualify to work off campus <u>without a work</u> <u>permit</u>. If you qualify, your study permit will allow you to:

work up to 20 hours per week during regular academic sessions and

work full-time during scheduled breaks, such as the winter and summer holidays or spring break. More information is found here:

<u>Co-op/internship Work</u> - Work Permit required for mandatory work experience in programs of study

If you are in a program that requires work-integrated learning, you <u>must</u> have a work permit. Immigration, Refugees and Citizenship Canada (IRCC, formerly CIC) refers to this as a co-op/internship work permit. This work permit is <u>in addition to</u> the 20-hour per week off-campus work authorized by your study permit. This means international students in programs with work-integrated learning require <u>a Co-op/Internship Work Permit</u>.
