### 4.2 Hand Rails Residence (Phase 1-3)

A railing or physical barrier should be installed outside the door as it's less than the 2m required to be away from the edge of the roof.

# 4.3 A Building Roof Access above Tim Hortons/Photography

The following access issues were reported:

- To get to the roof, employees have to access it through the little door on the second floor of A building. There is an area where they have to climb up 25" to access the equipment on the roof while carrying tools and parts.
- Area above the photography department is also a concern as employees have to climb up 45" to access that roof. The installation of steps is suggested.

### 4.4 T Building access to Chillers

It was reported that employees have to walk over the pipes for the thermal network to access the chillers. An installation of a bridge or walkway is required to get over them safely while carrying tools and parts. It's about 2' high and 4' long.
